## APPLICATION GUIDELINES

### EMERGENCY CONTROL ROOM ACHIEVEMENT

#### DESCRIPTION OF CATEGORY

Applications to this category may refer to either a remarkable innovation/use of technology or an extraordinary accomplishment. The innovation/accomplishment should have been implemented by an Emergency Control Room or an administration in the field of emergency services. This innovation/achievement should have contributed to the safety of citizens and to the progress of public safety.

Examples could include: implementation of new technologies to save lives, modernisation procedures, a major reform of the emergency call handling process, development of new tools to address major issues relating to emergency calls, a remarkable management of a crisis or disaster, a notable cooperation between emergency services in different regions or countries (list not exhaustive).

#### APPLICATION GUIDELINES

Please apply for this category using the online form. The *Application Description* should be uploaded as a **PDF file** in the final section of the form. Maximum file size 500MB.

In the *Application Description* section of the application, you should:

- Elaborate on the context and process of the innovation/achievement
- Explain the extraordinary nature of the innovation/achievement
- If relevant, please elaborate on the impact of the innovation/achievement, describing any relevant legacy
- The contact details of the nominee (if applicable).

## APPLICATION GUIDELINES

### EXTRAORDINARY CALL TAKER/DISPATCHER

#### DESCRIPTION OF CATEGORY

This category will award call taker or dispatcher who has contributed to saving one or several lives by going beyond the expected in their role. The call taker or dispatcher should have demonstrated an act of extraordinary bravery or responsibility.

Examples could include: remarkable management of a crisis or stressful situation, using innovative methods to help someone in need, a notable cooperation between different parties, going beyond the expected to save someone's life (list not exhaustive).

#### APPLICATION GUIDELINES

Please apply for this category using the online form. The *Application Description* should be uploaded as a **PDF file** in the final section of the form. Maximum file size 500MB.

In the *Application Description* section of the application, you should:

- Describe the extraordinary nature of the call
- Elaborate on why the response of the call taker or dispatcher was outstanding
- Explain why the intervention of the emergency service was extraordinary
- The contact details of the nominee (if applicable).

Examples could include: outstanding rescue, promotion of safety, initiative to improve safety of citizens, use of tech for good, performing first aid care in exceptional circumstances, any selfless act which has impacted someone's life/health (list not exhaustive).

In the *Application Description* section of the application, you should:

- Describe the extraordinary nature of the initiative/action
- Elaborate on why the intervention was extraordinary
